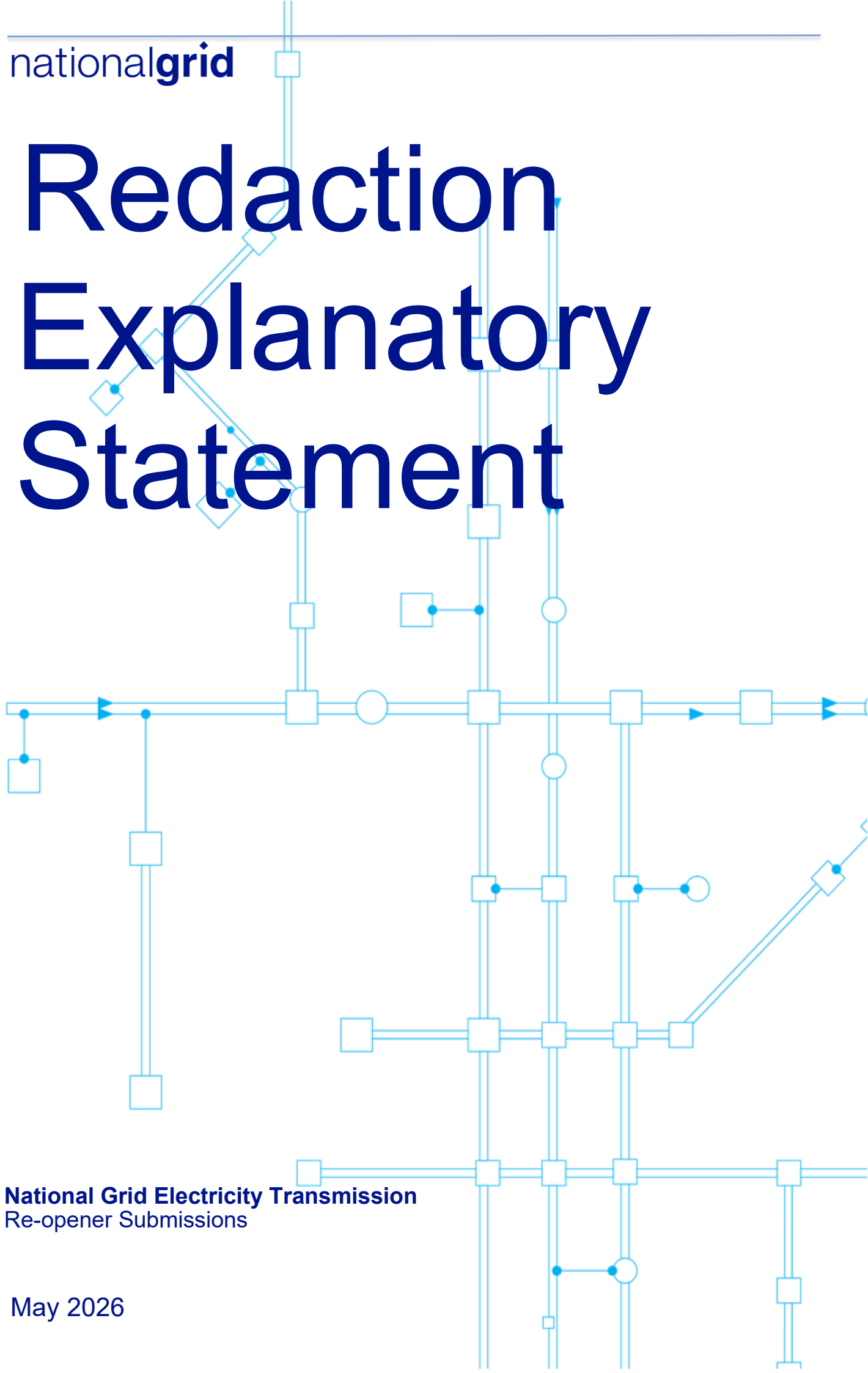

Redaction Explanatory Statement to accompany our published RIIO-T3 Re-opener and supporting documents

The summaries of the National Grid Electricity Transmission Re-openers published on our website on 15th May 2026 reflects the Re-opener submissions that we submitted to Ofgem on 8th May 2026.

By publishing summaries of these documents, we want to be open and transparent with our stakeholders to help stimulate constructive engagement on the content of our Re-openers. However, given the nature of our business it has been necessary to publish summaries of each re-opener to avoid sharing confidential information from the documents we are publishing. This statement explains the key types of information contained within our full re-opener submissions which prevent their direct publication.

Commercially Confidential information

Certain information contained within these submissions is classified as “Commercially Confidential” to National Grid Electricity Transmission as it contains competitively sensitive information. This type of information identifies or could reveal the cost data of our assets, operational land or activities that we source from third party providers on a competitive basis (e.g. goods and services in relation to the construction, operation and maintenance of our network). This includes information relating to the development of new substations and substation extensions. Publishing this data would be prejudicial to the commercial interests of National Grid Electricity Transmission and, as a consequence of this, would be prejudicial to the interests of consumers.

Chapter 1 of the Competition Act 1998 prohibits the exchange of competitively sensitive information, therefore publishing any of this type of information would be unlawful.

Information of this nature has not been included in the summaries.

Information has also excluded from the summaries on the basis that it relates to our future potential contractors and suppliers, which have not yet been subject to a procurement process. Publishing this information would be prejudicial to the commercial interests of National Grid Electricity Transmission and therefore our customers and end consumers.

Strictly Confidential information

Certain information contained within these submissions is classified as “Strictly Confidential” to National Grid Electricity Transmission as it is operationally sensitive information. This type of information identifies or relates to Critical National Infrastructure and/or sites, systems or processes that are used by National Grid Electricity Transmission for the safe, secure and reliable operation of the Electricity Transmission system. Publishing this information, which identifies or relates to system-critical sites, systems or processes (and proposed investments in relation to the relevant assets), would be prejudicial to the operational security of the Electricity Transmission system. Publication would prejudice the interests of consumers by potentially impacting the resilience and reliability of the service that consumers receive from us.

Third Party Information

Certain information contained within the submissions relates to or has been provided or produced by a third party. Information of this nature has been excluded from the summaries being published today where we do not have the permission of the author to publish this information.

Certain information within these documents relates to a particular third-party individual or business that may not be in the public domain. This type of information could, for example, reveal the identity of a customer, their proposed project type, their planned connection dates or estimated construction costs. Publication of this information could impact on the customer's business case and underlying project economics and could be detrimental to the customer's economic interests.

Section 105 of the Utilities Act 2000 provides that such information cannot be disclosed by us save in limited circumstances or with the consent of the individual or person carrying on the business. Information of this nature has been excluded from the summaries being published today where we do not have this consent.

For our re-opener Main Submissions, which contain Commercially or Strictly confidential information throughout, we have produced high level summaries.
